**Outdoor Lot Parking Agreement**

Commencing, on this date \_\_\_\_\_, \_\_\_\_\_ (parker), agrees to pay the current rate of **\$60.00** (sixty dollars) each month for one [1] parking access card. You are required to pay a **\$25.00** (twenty-five dollar) refundable deposit for your access card. The fee will be refunded upon termination or cancellation when the card is returned to us. There is a **\$25.00** (twenty-five dollar) fee for lost or replacement cards.

This agreement is in effect on a month-to-month basis and shall automatically renew month-to-month unless terminated by either party upon 30 (thirty) day written notice, excepting certain violations stated below and/or nonpayment of the required fee on or before the renewal day of the month. **Your parking card MUST be returned for your account to be cancelled.**

The first month that payment is not received prior to your due date, a delinquent fee of **\$20.00** (twenty-dollars) per card will be added to the regular monthly rate. Parking privileges for parking are revoked immediately until payment is made.

This agreement is not transferable. Customer understands that only the automobile listed herein shall be parked in the First Church lot. This parking agreement allows you to park in the specified lot. Storage of vehicle in the First Church lot is strictly prohibited and will result in immediate revocation of parking privileges.

*Motorcycles or scooters are discouraged because the in-ground exit sensors may not activate upon departure.*

Payments will be made online using the QR CODE above, select "recurring" option.

**Parker agrees Church sponsored events (i.e. funerals, worship, etc.) take precedence over permit parking. Advance notice will be posted when possible. Spaces will be limited at those times.**

**Parking in multiple spaces or in "made up" spaces will result in towing with all costs paid by parker. Do not block the entrance/exit, sidewalks, or north gate (emergency, waste access) to Chestnut Street.**

**Parker agrees to pay all costs of collection incurred by First Church, including attorneys' fees and expenses should applicant default on payment. A \$25.00 fee will be added to bank declined payments.**

**Parker agrees that First United Methodist Church of Des Moines is not liable for any damage to and/or theft of parker's automobile(s) and/or its contents.**
